STEP 5**Family Fundraiser Commitment and Share Hours**

It is through the continued support of our school and parish community that we are able to keep tuition costs as low as possible. As a school, we must raise approximately \$200,000 from fundraising to supplement tuition cost. With every family contributing a minimum required amount, we can help assure an equal and fair distribution of our school's fundraising needs.

Each family paying in-parish tuition is required to fundraise **\$600**. This commitment can be spread over a combination of the following opportunities:

School Auction

100% of in-kind services and auction procurement, 100% of paddle raiser, 100% of free dress tickets, 50% of Dinner Auction tickets and sponsor tables.

Annual Appeal

This fundraiser supports much needed financial assistance to qualified families. 100% of money donated will count towards your fundraising commitment.

Jog-a-thon

100% of money raised counts toward the fundraising commitment.

Scrip program

5% in SCRIP purchases will count towards your fundraising commitment. Family requirement for SCRIP purchases are \$1000 or \$500 (for single families).

SHARE Hours:

Each two-parent family paying in-parish tuition is required to volunteer 30 hours (single-parent 15 hours) in service to the school or parish community, 10 of which include Auction hours. All hours need to be recorded by the last day of school with Helpcounter.com. Unrecorded hours will be billed at the rate of \$30 per hour for general and \$50 per hour for Auction on the June tuition statement.

STEP 6**Contract Agreement**

I/We have read this contract, and agree to the terms and conditions stated. I/We also agree to pay St. John the Baptist Catholic School the tuition specified and fulfill my/our fundraising commitment and volunteer SHARE hours. I/We further agree to abide by the school policies and regulations as outlined in the school's Parent/Student Handbook and any addendums added by the principal, pastor or SAC. I/We also agree that if this note is placed in the hands of an attorney or collection agency for collection, I promise and agree to pay holder's reasonable fees and collection costs even though no suit or action is filed hereon; however, if a suit or action is filed, the amount of such reasonable fees shall be fixed by the court or courts in which the suit or action, including any appeal therein, is tried, heard or decided. I agree to all provisions as indicated above.
